 Runners have full use of road until the junction of Inkom Rd. and Old Hwy 91. From this point on, runners should run on side of road facing traffic. Vehicles could be present on all roads at any time.

Course marked with paint marks and washers/ nails embedded on side of road as if running course against traffic (runner's left).

- Start Even with 2nd telephone pole 104y S of stop sign at intersection of Crestview/Antelope. (N 42° 52.261' W 112° 20.053')
- 1 mile 104y W of west side of Timberline Rd. (N 42° 52.601' W 112° 19.313')
- 2 mile 97y E of stop sign at Mt. Meadow Dr. (N 42° 52.640' W 112° 18.217')
- 3 mile Adjacent to dam at Beaver Pond, no other landmarks. (N 42° 52.099' W 112° 17.358')
- 4 mile 139y SW of address post for 2673 Hoot Owl. (N 42° (51.705' W 112° 16.562')
- 5 mile 108y W of Speed Limit sign which is about .25 miles NW of 1825 Hoot Owl. (N 42° 51.348' W 112° 15.620')
- 6 mile 114y E of Curve warning sign with is .2 miles SW of 1493 Hoot Owl. (N 42° 50.989' W 112° 14.714')
- 7 mile 80y S of turn around marker. (N 42° 51.332' W 112° 14.356')
- Turn Even with unmarked Telephone Pole to east. Marker is also 62y S of green telephone box labeled with (TB) LP 1. (N 42° 51.358' W 112° 14.353')
- 8 mile 69y E of mail box for 5937 Rapid Creek Rd. (N 42° 51.071' W 112° 13.461')
- 9 mile 84y S of mail box for 5261 Rapid Creek Rd. (N 42° 50.412' W 112° 13.017')
- 10 mile 30y N of yellow gravel driveway, or 110y S of green telephone box RPTR SE 18-2. (N 42° 49.563' W 112° 13.120')
- 11 mile 26y N of green telephone box # 13-5, Rapid Creek Rd. (N 42° 48.739' W 112° 13.356')
- 12 mile Even with mail box at 2630 Jackson Creek (N 42°48.024' W 112° 13.802')
- 13 mile 33y S of mailbox for 1791 Inkom Rd. (N 42° 47.249' W 112° 13.341')
- ½ Start (Not Certified) 1y SW of telephone box RL 8A and even with NE driveway for 1674 Inkom Rd. (N 42° 47.161' W 112° 13.306')

- 14 mile 108y W of East side of I-15 bridge. (N 42° 47.236' W 112° 14.109')
- 15 mile 25y W of Main Street/Hwy 91 junction. (N 42° 47.607' W 112° 15.179')
- 16 mile At orange post on North side of Hwy 91 (in 2nd dip past stop sign), or 126y E of mail box for 2465 HWY 91. (N 42° 47.949' W 112° 16.228')
- 17 mile 20y E of address post for 3397 Hwy 91. (N 42° 47.923' W 112° 17.405')
- 18 mile 82y E of mail box for 4441 Hwy 91 adjacent to pole fence. (N 42° 47.797' W 112° 18.564')
- 19 mile 41y E of mail box for 5406 Hwy 91. (N 42° 47.789' W 112° 19.735')
- 20 mile Even with telephone pole at historic turnout in GAP, OR 33y E of pipeline marker 12-41. (N 42° 47.733' W 112° 20.914')
- 21 mile 166y NE of 35 mph curve speed limit sign. (N 42° 48.049' W 112° 21.832')
- 22 mile 30y S green telephone box 7295 across from Big Springs drive. (N 42° 48.747' W 112° 22.533')
- 23 mile 90y S of green telephone box, or 197y S of 5K start. (N 42° 49.381' W 112° 23.342')
- 5K Start (Not Certified) Even with flagpole in front of County Jail. (N 42° 49.444' W 112° 23.442')
- 24 mile Even with N side of driveway for Rimrock Bar. (N 42° 49.998' W 112° 24.167')
- 25 mile 10 y south of 2nd telephone pole south of Avenue of Chiefs Dr. (N 42° 50.624' W 112° 25.009')
- 26 mile Directly across from South side of North driveway for Ross Park pool. (N 42° 50.623' W 112° 25.383')
- Finish Ross Park, 1st pole south of Band Shelter, or adjacent to pole 012, F136, 15T. (N 42° 50.444' W 112° 25.297')
